Ecological University of Bucharest is determined to improve the quality of its activity followed by an increasing number of first year students and higher education graduates.

In order to improve the quality and relevance of teaching and researcher training, to equip graduates with the knowledge and core transferable competences, each study program and each course (in all BCs and MSc) has a list of competences gained by the students after graduating that course. Depending on each specific topic, many courses include research activities both in the E.U.B.'s laboratories, in National Research Centres and in international Placement institutions. Since adhering to the Erasmus University Charter, E.U.B. has permanently increased the number of students involved in study or placement abroad and their good practices contribute to mobility expansion.

To strengthen the "knowledge triangle", linking education, research and business E.U.B. actively involves its students in research projects that involve international experts. In the development of the study programs, EUB consults its formers students that are now members of an Alumni Association and provide information about what the job market requires from the future graduates. Also, research specialist and business leaders are frequently invited to lecture in front of the students on the latest developments of their fields. The Programme will allow us to invite teaching and research staff from our partner universities and to encourage the knowledge transfer
